Road markings outside the village hall – The work is complete now.

Cleaning of War Memorial – There is no update.

Repair of Fingerpost in Lower Tadmarton – There was little to report and no progress has been made. The matter is in the hands of OCC and the drivers insurance company. There is concern at how long this is taking to move forward.

Action: The Parish Clerk is meeting Dave Catling of Highways about another village matter on 7th December and will speak to him for an update.

Yellow lines along the Main Road – The Parish Council are awaiting a price for the work from Highways.

First Aid Defibrillator Training – There was no update. A course will be arranged in the New Year.

Bakers Lane nameplate – It has been ordered. Awaiting delivery.

New dog bin for Upper Tadmarton – The Parish Clerk will order a bin.

New Speed signs – The pole signs to support Speedwatch will be ordered.

The flooding in Lower Tadmarton was reported on Fix My Street and has been fixed.

A villager complained about excess water on Stant Hill. The issue is a leaking spring. It has been reported to OCC Highways and on Fix My Street.
